Call for Papers: ABS/SWS Meetings

The Association for Black Sociologists is teaming up with Sociologists for Women in Society for the 6th Annual Student Roundtables: Emerging Scholarship in Sociology. The session will take place at the Paris Hotel on August 20th.

Emerging Scholarship in Sociology will feature research by students who are in varying stages of their academic career. This session will provide an opportunity for student presenters to discuss their research interests, plans and goals with other students and faculty facilitators. The main purpose of this session is to create a comfortable and inviting environment where relationships among students with similar research interests can be established and valuable feedback obtained from supportive professors. We encourage participants to maintain and build on these relationships as sources of support and encouragement as they continue to develop their work.

The general topics for this roundtable are race, gender, class and sexuality, and submissions should deal with one or more of these issues. Student members of SWS and/or ABS are eligible to present in this session and presenters much be registered members of either ABS annual meeting or the SWS summer meeting by May 27th, 2011. papers from both graduate and undergraduate students will be accepted.

All submissions should include: organizational (either ABS or SWS) and institutional affiliation; contact information, including phone and e-mail; the present stage of your study (e.g. undergraduate senior, year in graduate program); three to four keywords associated with your work; and an abstract or proposal of the work which you will be presenting (under 250 words). The completed paper will be no more than 5,000 words in length and will be submitted by July 15th.

The center for Digital Ethics & Policy at Loyola University Chicago will be holding a Digital Ethics Symposium on October 28th, 2011 and encourage papers on digital ethics which would first be presented at the symposium, with the best of those then included in an edited volume on digital ethics.

Authors of accepted papers will be eligible for up to \$400 in travel funds to be able to attend the Chicago symposium. The author(s) of the top student paper will be eligible for up to \$1,000 in travel funds.
