### News from the 2005 CLD Business Meeting: Membership Again Near 600

The 2005 Business Meeting of the Crime, Law, Deviance Section of the American Sociological Association was held at 11:30am on Sunday, August 14, 2005 in the Commonwealth B Room of the Loew's Hotel in Philadelphia, Pennsylvania. Approximately (40) attendees were present at the business meeting.  
**Ruth Peterson**, CLD secretary

treasurer, gave the membership and treasurer's reports. Membership was at 564, including 188 (33%) students, 357 (63%) faculty, and 19 (3%) low income members. This means that the level of membership is 36 short of the 600 members required to have 3 panel sessions and a roundtable session at the 2006 annual meeting of ASA. Members are encouraged to be sure to pay dues by September 30 of every year as that is the usual date for determining the allocation of sessions for the following year. Members are asked to encourage others to join the section by that time.

### An Invitation to Join the Sociological Practice Section

The Sociological Practice Section of the ASA would like to invite members of the Crime, Law and Deviance section to join our section. As is the case with many Crime, Law and Deviance section members, Sociological Practice section members are dedicated to the realization of public sociology. Strategies based on emerging best practices and evidence-

based practices (EBP) will be highlighted. The Sex Work Matters project provides scholars, activists and analysts with a platform for multi-disciplinary, cross-institutional exchange of ideas and networking. In addition to featuring high profile leaders and scholars, the conference in March 2006 will offer a much-needed opportunity for graduate students, sex workers and activists to enter the debate, present original work and identify areas for collaboration. Additional events organized to complement the conference include the Sex Workers Soiree and other networking opportunities with local organizations and sex workers, roundtable mixers featuring established scholars and activists and 4-6 graduate student panels including faculty and activist commentators. The **Sex Work Matters** project invites sub-missions of abstracts of work exploring the economic, social, cultural, and political aspects of sex work.
