**ASA Task Force on Sociology and Criminology Seeks Input from Crime, Law and Deviance Section Members.**

The American Sociological Association (ASA) Task Force on Sociology and Criminology Programs is requesting input from faculty members in Criminology, Criminal Justice, and Sociology programs on

issues and problems in the relationships among these related fields. The Task Force, chaired by Dennis MacDonald of Saint Anselm College, has been charged with "developing model curricula and sample course content for courses in criminology taught in sociology departments" at the BA, MA, and PhD levels. In addition, the Task Force is examining the relationships between Sociology and Criminology/Criminal Justice programs that are in separate departments. The resulting report will provide guiding principles and recommendations, as well as illustrations ("promising practices") for how departments of various types offer strong criminology programs within sociology departments, and how optimal relationships can be attained and maintained when Sociology and Criminal Justice/Criminology reside in separate departments. The Task Force, which is currently interviewing department chairs, is particularly interested in comments from all faculty members on issues and problems, the variety of program structural arrangements, programs and relationships that work well, and information on existing data relating to these issues. 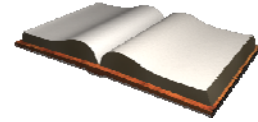
