Petition to Change Constitution and By-Laws: Referendum

Petitions were received in the ASA Executive Office proposing changes in the ASA Constitution and By-Laws. The number of valid signatures received exceed the required 3% of voting members. Therefore, the petition will be subject to a referendum by the membership.

Council received the petition at its December meeting. It is reprinted in this issue of FOOTNOTES as part of the Council minutes. As the minutes indicate, Council discussed the submitted petition and voted, with one negative vote, in opposition to the petition and in support of the current Constitution and By-Laws.

OFFICIAL REPORTS AND PROCEEDINGS

MINUTES OF THE 1976 COUNCIL MEETING

The second meeting of the 1976 Council convened at 10 a.m., December 5, 1975 in Washington, D.C., President Alfred McClung Lee presiding. Those members present were: Kurt W. Back, Lewis A. Coser, Cynthia Fuchs Epstein, Kai T. Erikson, Joseph Fichter, William H. Form, Renee Fox, Joan Huber, Alex Inkeles, Suzanne Keller, Lewis M. Killian, Melvin L. Kohn, Gary Marx, Hans Mauksch, Pamela A. Roy, Peter I. Rose, William F. Whyte, and J. Milton Younger. Those present from the Executive Office were Alice F. Myers, Philip Carey, Lucy Sells, and Sally Mitchell.

1. Approval of the Agenda: The agenda was approved as presented.

2. Report of the President: President Lee reported as follows:

The Council has before it a very full agenda, but there are several items that require prompt and decisive action.

Some four hundred members of this Association have signed a petition to change our nominating and voting procedures in an important respect. To judge from reactions to the petition that have reached me from many parts of the country, we could have had a great many more signatures than that, but only some 250 were actually needed.

As you all know, that many signatures on a petition mandates a referendum—a prompt referendum—of the membership on the issue raised. I am, therefore, concerned that the petition is item 16 on the agenda and that it is slated for discussion on Saturday afternoon when some of you may have to leave early to meet other obligations. The Council has every right to offer alternative proposals to those advanced in the petition for consideration by the membership at the same time. If such alternatives seem desirable to the Council, I hope they can be formulated before the end of these meetings so that we do not delay the referendum beyond the time of the mailing of the forthcoming election ballot.

With the extensive and helpful cooperation of Hans Mauksch and Alice Myers, the work of setting up the 1976 convention program appears to be proceeding on schedule. We will know more about the volume of papers and other details of participation by the next Council meeting. The quantity of correspondence and telephoning this all requires from my office alone, not to mention the ASA headquarters and the offices of all the cooperating committee, section and session chairpersons and members around the country, is rather overwhelming but quite necessary. I want to commend the intelligence and efficiency of all the people involved in this complex effort.

I am very much impressed by the quality and direction of many of the motions carried at the annual membership meetings. I would like to comment on what appear to me to be the most urgent issues they bring before us:

The severe cutbacks in teaching and research budgets present this Council with problems that are becoming increasingly serious and pressing. Responsible leaders are now appropriately calling for united efforts to maintain the quantity and integrity of our intellectual institutions and for the equivalent of the Works Progress Administration (WPA) of the 1930's to provide professional employment on useful projects for intellectuals, artists, and technicians.

At this meeting, we are to discuss the future of certain committees that should be dealing forcefully and realistically with aspects of this growing problem. In my estimation, the chief obstacles ASA committees face in this area are not due to lack of ASA financing. I am speaking especially about our committees on employment and integration of research and teaching. Their chief problems have been those of divided loyalties or even of conflicting interests.

Our committees typically represent most directly the entrenched, the successful. The problems of employment have to do most importantly with women, nonwhites, and dissidents who have struggled for years to gain footholds in our profession and who have made those gains so recently as not to be tenured. In a great many cases, they are the most recently hired, the least likely to be tenured, and the least likely to be let go to meet alleged budgetary limitations. Too often considerations of qualification and accomplishment, of enrichment of student experiences or strengthening of a research staff, are brushed aside. What is our committee on employment doing in behalf of these untenured people? For that matter, what is it doing to cooperate with other educational bodies to turn the tide against budget cuts? In view of the character of our committees and of their apparent definition of their constituencies, what can they be expected to do in behalf of such people?

The work of the committee on freedom of research and teaching is typical of the employment problem as well. Many of the cases of unfair academic practices do not involve actions primarily by a college president or dean but by tenured members of our own profession. In case after case, it is an overly self-protective department chairperson or group of tenured professors on a

personnel committee who try to handle the problem of competition by keeping the so-called "revolving academic door" revolving, especially when those who are not to be retained are female, nonwhite, innovative. What is our committee on freedom of research and teaching doing to help cope with this situation? In view of the character of our committees and their apparent definition of their constituencies, I repeat, what can they be expected to do in behalf of such people?

Without citing specific cases at this point, I know of a number of instances in which the ASA did little or nothing because the issue was one of the violation of academic due process by a member or group of members of the ASA. I could document this point quite heavily. I am also not overlooking the cases where we failed adequately to challenge unprofessional actions by deans and presidents.

We need a reasonably autonomous and representative body that will start to fight now for the retention of gains made by minorities, and dissidents in particular and for the expansion of those gains. We also need at the same time, as I mentioned a new Federal WPA program. If we value the future of our profession we will put finances and energetic personnel into both of these efforts.

It is suggested in the agenda that the committees on information technology and privacy, on professional ethics, and on freedom of research and teaching might be discussed as a "package." I have even heard it suggested that these three might be merged. They would not be looked upon as a "package" by a very large share of our membership. The committees on information technology and privacy and on ethics deal principally with problems of concern to the entrepreneurs of our field, the heads of variously funded research projects. Most sociologists have no trouble with problems of the invasion of privacy or with the definition of ethical practice. This is not because they are inactive in research and teaching but because they are operating in terms of generally accepted rules of good professional behavior. But freedom of research and teaching concerns a great many of our members, especially those who are untenured, innovative, and not inclined to be mere followers.

What I am saying is that these should be treated as two packages: Information technology and privacy and professional ethics are chiefly of concern to the "haves," those who have arrived and who wish to push further. Freedom of research and teaching also generally accepted rules of good professional behavior. But freedom of research and teaching concerns a great many of our members, especially those who are untenured, innovative, and not inclined to be mere followers.

What I am saying is that these should be treated as two packages: Information technology and privacy and professional ethics are chiefly of concern to the "haves," those who have arrived and who wish to push further. Freedom of research and teaching also generally accepted rules of good professional behavior. But freedom of research and teaching concerns a great many of our members, especially those who are untenured, innovative, and not inclined to be mere followers.

In closing, I should like to bring you greetings from the New York State and the Michigan Sociological Associations. I was privileged to speak before them recently and also at some other colleges here and there and at the University of Texas at Arlington. The general message that I received in all of these places from quite large groups of sociologists is that they are hopeful that the ASA is really moving towards becoming a more representative and democratic organization and that evidences of that movement will continue.

3. Report of the Secretary: Secretary Form reported that Robin M. Williams, Jr. had accepted the appointment to a three-year term as editor of the ASA Rose Monograph Series, beginning in January, 1977 and that Karl F. Schuessler has accepted the editorship of *Sociological Methodology* for the same term. The economies planned in the publications areas were being implemented but some economies were creating problems needing resolution by the Committee on Publications. Such actions will be reported to Council in March.

4. Report of the Executive Officer: Hans Mauksch reported on the current state of negotiations with three private foundations for funding of three separate proposals. He indicated that a contract had been signed with Free Press for the publication of the book *Sociological Methodology: The Uses of Controversy*; negotiations had been completed with Allyn and Bacon for the revision of the secondary school introductory sociology text; and Cambridge University Press has indicated strong interest in publishing the Rose Monograph Series, including handling of those already published. Mauksch reported that, according to his observations after his first three months as Executive Officer, sociology seems to have very little input into the policy-making process in Washington and that, hopefully, this situation could be improved by organized, concerted action. He cited issues affecting the utilization of three committees to be discussed later on the agenda as examples of opportunities for greater effectiveness. He briefly outlined his plans for one or more workshops hopefully producing position statements, recommendations, and strategies for the involvement of sociology in the areas of federal guidelines and policies

affecting conditions of research and teaching, privacy, data access, information technology, and protection of human subjects.

5. Committee Review.

a. Committee on Regional Affairs. A report was presented recommending actions which might bring about more involvement of the regional societies in the affairs of the ASA. Council discussed ways in which the regional societies and the national organization might benefit each other including input into each others' newsletters, building of membership rolls, closer communication among counterpart committees, and a possible liaison part-time staff person with the regional societies. Such a position would need financing, with contributions from each of the seven regionals. Some reservations were expressed about the need and desirability of such a liaison staff person and Council decided to take the issue back to the regional societies for further clarification through the following motion:

MOTION: Having taken account of the Committee's report, Council favors informing the various regional and state organizations that it supports optimal relationships with them and suggests that the Executive Office arrange a meeting of designated representatives of these societies on the day preceding the Annual Meeting. The agenda of this meeting should include all aspects of this relationship and the implementation of them including the possible need for a part-time staff member in the national office and budgetary considerations of such a position. Carried.

b. Committee on Training and Professional Standards. Because there was no report, no action was taken.

c. Committee on Information Technology and Privacy. Council expressed the need for the continuation and reactivation of this Committee in line with the important political implications of the charge to this Committee. Further action was taken after discussing the next Committee.

d. Committee on Professional Ethics. Responding to a communication from the Committee and to previous comments from the Executive Office, Council discussed the need for the gathering, integrating, and assessing of information about a range of issues affecting ethical aspects of scholarship.

MOTION: That the Executive Officer convene a workshop involving selected members of these two and other policy committees and other appropriate individuals for the purpose of clarifying issues and presenting alternative recommendations for Council action. Carried.

e. Committee on Freedom of Research and Teaching. Council recognizes that the membership is not well informed about the activities of this and other major policy committees and seeks a remedy with the following action:

MOTION: Each Standing Committee of ASA, excluding the Awards Committees, hold an open meeting or organize a panel discussion on the work of the Committee at each Annual Meeting of the Association. Carried.

Based on further discussion of this motion, Constitution Committees are also to be excluded. Open meetings or panel discussions should include opportunities for audience participation; these meetings could be as formal or as informal as appropriate; separate closed meetings of all committees would continue. Ad Hoc Committees could participate if they desired.

Council returned to a discussion of the future of the Committee on Freedom of Research and Teaching, deciding that, though limited in scope, this Committee should continue. A communication from the acting chair of COFOT regarding the Committee's possible functions was discussed. After exploring the roles of a variety of other organizations active in this area, the following two motions were passed:

MOTION: That Council urges the President to enter into discussions with other relevant professional associations to explore the possibility of creating a jointly-sponsored organization modeled after the ACLU and specializing in investigating academic freedom cases. Carried.

MOTION: That Council approves, as part of the Committee's mandate, the proposal incorporated in Wilson Record's report of November 25: "Even if COFOT report is supported as suggested above, it could still perform some valuable services for ASA members. It could, for example, draw up and publicize model contracts and develop guidebooks for faculty and administrators in hiring, promoting, and retaining sociologists. It could also seek funds for research confront sociologists as a group in pursuing their academic careers. It could get out an annual report on the status of academic freedom for sociologists." Carried.

f. 1) Committee on Employment. This committee will be continued after reconstituting the membership.

f. 2) Committee on Government Statistics. Council passed a motion to continue this committee.

f. 3) Committee on Environment. Now that a Section on Environment is being organized,

Council decided to disband this Committee.

f. 4) Committee on Guidelines on Non-Sexist Terminology. A report will be presented to Council at its next meeting, after which the Committee will be terminated.

f. 5) Committee on Non-Academic Sociologists. Council accepted the report of this Committee including its recommendation for disbandment.

6. Committee Appointments. Chairpersons were selected for all Committees. Some additional appointments were made to several committees; Paul Sheatsley was appointed as ASA representative to the Committee on Public Attitudes Toward Survey Research; and two Council liaisons were designated, Kurt Back to the Committee on World Sociology and Pamela Roby to the Project on Undergraduate Sociology. (Roby later withdrew from this appointment.)

7. Editor for Sociometry. Council reviewed and then rank-ordered the list of candidates provided to it by the Committee on Publications and instructed the Secretary to proceed with the appointment.

8. Committee on Procedures for the Annual Business Meetings. This Committee had been charged with designing procedures for the orderly conduct of the Business Meetings resulting from the recently approved By-Law amendment concerning members' resolutions. The chair of this Committee elaborated on the written document presented as a motion to Council containing its recommendations, as follows:

MOTION: The Committee recommends that:

a. The Secretary of the Association shall open each Business Meeting by reading those articles of the Constitution pertaining to voting privileges and to members' resolutions. The Secretary shall also inform those in attendance what number constitutes three percent of the voting membership as of August 1 of that year.

b. The Presiding Officer of the Business Meeting shall announce before each vote taken on resolutions from the floor that only Members of the ASA have the constitutional right to participate in the vote about to be taken.

c. Voting will then follow according to the procedures now in effect, with the Secretary responsible for counting votes and announcing the official tally. In addition, the Secretary shall appoint official tellers in advance of the meeting and position them throughout the floor at his or her discretion.

d. The present Ad Hoc Committee on Procedures for the Annual Business Meetings should have its appointment continued until the December meetings of the Council, at which time the Committee will submit a report on problems arising from the 1976 Business Meetings together with whatever further recommendations seem appropriate.

After considerable discussion the motion was carried.

9. Section on Sociology and Population. After receiving assurances that a proper petition containing the required number of valid signatures had been received, Council approved acceptance of this as a Section in formation. The privilege of holding an organizing meeting at the 1976 Annual Meeting is accorded this group.

10. Photographs as Inclusion in Information on Candidates. Council's advice was requested by the Executive Office staff on whether to continue photographs. The original decision to include photos was not a Council action, but advice was being sought because of some reluctance expressed on the part of some candidates.

MOTION: That when candidates are invited to accept the nomination, they be advised that supplying a photo is a matter of personal preference. Carried.

The information on the candidates supplied to the membership should include a note explaining this policy.

11. Committee on the Problems of the Discipline. An evaluation of this program, following two years of funding, is in process and will be available at a subsequent Council meeting. The Chair of the Committee indicated a request for 1976 funding will be made. Council approved a motion to accept the report.

12. Resolutions from the August Business Meeting:

a. RESOLVED: That the ASA take a census of all sociologists to determine the degree of unemployment, part-time employment, and employment unrelated to training and background.

MOTION: That this resolution be referred to the Committee on Employment for recommendations on implementation. Carried.

b. RESOLVED: That the ASA reduce dues for unemployed sociologists to the level paid by students.

MOTION: That Council authorize the Executive Office to use its discretion to waive dues on a year by year basis for members of the association who are temporarily unemployed. Carried.

c. RESOLVED: That the chairpersons of sessions ask that smoking be confined to that half of the room to the speaker's right.

MOTION: That Council adopt this resolution. Carried.

d. RESOLVED: That Sociologists for Women in Society wishes the privilege of honoring the memory of Caroline B. Rose, an eminent and respected sociologist as well as a great feminist, who died this year.

MOTION: That Council adopt this resolution, instructing the Executive Officer to write the Rose children of this action. Also, that FOOTNOTES publish annually a list of members who have died within that year. Carried.

e. RESOLVED: 1) That the Executive Specialist for Minorities and Women be empowered to find actuarial data on the comparative life spans of "equally situated" academics who are male, female, black, white, Hispanic, Oriental, and of any other social characteristic relevant to differences in their life spans, and 2) that these data be brought to the attention of the appropriate Federal Agencies currently arguing this issue in Federal District Courts, with the goal of ending sexist discrimination in college and university pension plans.

MOTION: That ASA support efforts to gain equality on the basis of sex in the pension and retirement system for all institutions for pension and insurance plans. Carried.

A subsequent motion to forward this resolution to the Committee on the Status of Women in Sociology was withdrawn and the Executive Office was instructed to implement the action of Council.

f. RESOLVED: That SWS 1) expresses concern for ASA accountability, 2) requests the Executive Officer to trace the steps taken to implement resolutions passed at the Business Meeting and ratified by the Council, and 3) requests the publication of such information prominently in FOOTNOTES.

The whereas portion of this resolution contained references to previous resolutions concerning pay toilets in the hotels and child care service at the Annual Meeting. Council was informed that the pay toilet issue had been resolved and that, in addition to other favorable reports, a letter of commendation had been received from SWS concerning the conduct of the child care service. Therefore, no action was deemed necessary on this resolution.

g. RESOLVED: 1) That we, the members of ASA, condemn the repression of intellectual freedom in Chile and U.S. support thereof; 2) that the Chilean junta release all political prisoners; 3) that all political refugees from Chile who so choose be granted haven in the U.S.; 4) that the ASA form a committee to present these resolutions to the appropriate U.S. and Chilean authorities, and 5) that the committee demand (Council changed this wording to "that the ASA ask for") an accounting of the sociologists now missing.

MOTION: That Council endorse the resolution after making the change noted above. Carried with one dissenting vote.

h. RESOLVED: 1) That the ASA go on record of supporting federal legislation to: a) expand existing public service employment programs; b) establish new public employment programs designed to provide needed services and public works projects of lasting value; c) establish special projects to utilize the skills of unemployed persons; and d) assist and support those groups most depressed by the economic crisis; minority groups, the economically disadvantaged, the long-term unemployed, and urban residents. 2) That the Committee on Government Statistics investigate and report back to the membership their recommendations for revising the Department of Labor's methods of defining and reporting unemployment rates, so that citizens and social scientists will have realistic data to use as a basis for planning, research, and critical analysis. 3) That the President of the ASA report to the general public the pertinent data on unemployment and the economic crisis, and the above position of the Association, and that the President formulate specific recommendations for public policy required to alter economic conditions. The President is particularly charged with developing public policy recommendations based on sections 1) and 2) of this resolution, and with reporting those recommendations to relevant Congressional hearings and committees, legislative study groups, and appropriate federal departments.

Council discussed the fact that ASA cannot support legislation or take any action that could be so construed and would, therefore, limit its actions to the support of programs.

MOTION: That Council delete item 2) because other organizations, including the ASA Committee on Government Statistics are concerned with this issue; and that the ASA Committee on Employment be requested to implement the concerns expressed in item 1) Carried.

i. RESOLVED: That the ASA extend its thanks to Joan Harris, the ongoing Executive Specialist for Women and Minorities, for a job well done.

MOTION: That Council adopt this resolution. Carried.

j. RESOLVED: That the ASA mandates the President of the ASA to take such action—in association with the President of the Canadian Sociology and Anthropology Association—as will discourage violations by American social scientists of the Canadian

and international censure-boycotts of Simon Fraser University.

Council received a telegram from the President of the Canadian Sociology and Anthropology Association relating that organization's current position, reiterating its continued boycott with hopes of a resolution of the situation in the near future.

MOTION: That Council reaffirms its past resolution to support the CSAA in its actions with respect to Simon Fraser University. Carried.

RESOLVED: 1) That the Committee on Freedom of Research and Teaching be continued, 2) that the Committee as in the Simon Fraser case, establish investigative teams to conduct on site investigations of violations of academic freedom, 3) that the Committee initiate a program for support of victims of political discrimination, 4) that the formation of a special fund for the investigation teams, for legal advice and for the support of victims of academic repression, be developed in part from assessments of members of the Association and in part from voluntary contributions to special events, 5) that the members of the Committee and its investigative teams be drawn from a broad spectrum of political orientations, 6) that, in addition to a vigorous program for defense of academic freedom, a broad inquiry be undertaken by the Committee into the mechanisms of academic repression, including the new forms of this repression which are associated with the current budget cuts in the universities and colleges; 7) that the inquiry should include the formulation and dissemination of a summary of previous successful investigations, as well as the problems related to those investigations; and 8) that the inquiry should produce recommendations for constructive and comprehensive series of actions to protect subjects from political discrimination.

Recognizing that this resolution was a result of concerns that Council would be considering the disbandment of this Committee and that Council had not done so as reported above, no action was taken on this resolution.

RESOLVED: That the ASA views with concern the effort being made to exclude Israel, on political grounds, from United Nations' organizations and activities in the fields of education, science, culture, and social welfare, in particular, we oppose the exclusion of Israel from UNESCO regional groupings and UNESCO activities, and the attempts being made to exclude Israel from the forthcoming UN conference on Habitat.

Council adopted this resolution at its August meeting because of the deadline imposed by the scheduled UNESCO meeting in October. It is being reported here to record Council action within the proper context.

RESOLVED: That Council examine alternative mechanisms for continuing monitoring of oppression of our sociological colleagues in any country of the world and for taking timely, concerted action to protect sociologists against such oppression. The examination should include attention to the formation of an Amnesty International chapter of sociologists, section in concert with sister American social science associations and action through the International Sociological Association.

MOTION: That this be referred to the Committee on World Sociology for recommendations and implementation. Carried.

RESOLVED: That the Council of the ASA be requested to obtain from the Social Science Research Council information about the size of its professional staff, the number of staff people and committee members who are male or female, and the number of staff people who are black, white, Hispanic and other minority. Be it further resolved that the Council of the ASA be requested to inquire of the SSRC whether it has a policy regarding affirmative action and the diversification of its professional staff, and what has been the result of such a policy.

MOTION: That Council adopt this resolution and that a letter signed by the President of ASA be sent to SSRC making the appropriate inquiries. Carried.

RESOLVED: That the ASA goes on record supporting the United Farm Workers in its lettuce, grape, and Gallo wine boycott which should continue not only until there are elections but also until contracts are signed based on the elections.

Council discussed the appropriateness of adopting an official ASA policy on this issue and agreed that this issue should be considered one for individual concern. Council therefore decided not to take action on this resolution.

RESOLVED: That the American Sociological Association expresses its heartfelt thanks to Otto N. Larsen for his outstanding performance in service to the membership during his three years as Executive Officer. He has proved himself organizationally skillful, pragmatically creative, and interpersonally humane, and for all this, we are grateful.

MOTION: That Council adopt this resolution. Carried.

13. Committee on the Status of Race and Ethnic Minorities in Sociology. This report contained three resolutions, as follows:

RESOLVED: a. That the situation of underutilization of minority sociologists be immediately rectified by the President-Elect, Council, and Committee on Committees to insure adequate appointive representation on all ASA committees.

b. That the position of Executive Specialist for Women and Minorities be divided into two separate ASA funded positions—one of these positions should be called "Executive Specialist for Racial and Ethnic Minorities" and the other should be called "Executive Specialist for Women." Be it also resolved that funds be immediately appropriated for the establishment of and hiring of personnel for both positions.

c. That the Committee on the Status of Race and Ethnic Minorities in Sociology report to all members at no cost and that institutions and non-members be charged a fee of \$2.00 per copy. The Executive Officer should seek the necessary funds to assure publication and distribution as outlined above.

In the ensuing discussion, an analysis of the 1975 committee roster indicated that 25 (21%) of the 120 people listed as committee members were minority members. Twelve (71%) of the 17 committees had one or more minority members. No data is available on the percentage of minority members on the ASA membership roster because such designation is on a voluntary basis. However, some estimates suggest that minorities constitute approximately 2% of the total membership. Recognizing that there is a high representation of minorities on the Committee on the Status of Racial and Ethnic Minorities in Sociology and the Committee on the Minority Fellowship Program, these two lists were deleted from the statistics, dropping the 21% representation to 17%.

Further discussion centered on information presented to Council concerning the difficulty of identifying minorities as part of the Committee on Committees and the difficulties facing the Committee on Nominations when seeking to involve minority group members by having many of them decline nomination to run for office.

MOTION: That Council continues to encourage greater participation and utilization of minority group members on its committees. Carried.

MOTION: That part "b" be referred to the Committee on the Executive Office and Budget for consideration of the current work load and the budgetary considerations of this section of the resolution. Carried.

MOTION: That part "c" be tabled pending receipt of the CSREMS report. Carried.

14. Task Group Meetings. Council members met in three separate task groups to further their discussions on long range planning. This program was begun during the August Council meeting and will continue through the March meeting. Following that meeting, each task group will prepare reports and recommendations for Council consideration in June to be reported to the membership in August.

Following these sessions, each task group reported back to Council as a whole on their discussions, as follows:

Task Group I, Development. Discussion centered about the four stages of development of knowledge: 1) attracting people into the field; 2) training them; 3) keeping continuing research opportunities open; and 4) presentation and publication of results. These are financial issues involved as well as qualitative factors. The group will probably recommend the publication of notes in the newsletter about research opportunities from the federal agencies and additional allocation of pages to the journals to aid in the dissemination process.

Task Group II, Dissemination. This group was concerned with two types of dissemination: outside the discipline and the possible vehicles for accomplishing this, and within the discipline by means of journal publications. The task group will probably recommend additional press involvement aside from the Annual Meeting, aided by a Media award and a possible grant for a staff member to explore possibilities of more outside dissemination. Internally, the task group is exploring the possibility of revising the ASA publications series for greater effectiveness.

Task Group III, Utilization. The group discussed the differences between the uses of sociologists and the use of sociology. They also attempted to identify the risks sociologists felt inherent in the use of their research in seeing research used wrongly, danger of research used to control people, risk of sociology oversell, ethical uses of research, and risk of becoming outmoded.

15. Open Council Meetings. The ad hoc committee appointed at the August meeting presented its recommendations to Council. Following thorough discussion of the value and possible deterrents to these recommendations, Council revised the statement and adopted it as follows:

MOTION: (1) ASA Council meetings shall be open, except for the discussion of personnel and related matters, to members of ASA, the number of observers not to exceed the number of Council members. 2) Those intending to attend a Council meeting as observers shall notify the Executive Office at least two weeks before the date of the meeting and shall be admitted according to the following order of priority: a) Observers who are elected or selected as official observers by state and regional sociological organizations, sections and caucuses of ASA and ad hoc groups in order of priority according to the size of the organization. b) Individuals who represent only themselves in order of their arrival.

3) Members who wish to speak to the Council shall make their requests to the Secretary, and have their requests granted upon a majority vote of the Council.

4) Council shall periodically hold hearings in conjunction with a regular meeting on important themes of general interest, either on its own initiative or in response to a petition from 50 members.

5) Council shall make a report to the ASA membership and hear questions and comments from the membership at a business meeting at each Annual Meeting. Carried.

MOTION: That, aside from the Annual Meeting, at least one other Council meeting will be held in an area of the country related to a regional society. Carried.

16. Petition from the Membership. The following petition signed by more than the required three percent of the voting members of the Association was presented to Council for action:

"In order to achieve more direct representation of the whole membership in the principal elective bodies of the Association, I hereby request that the Association's vote tabulation procedures, and in order to improve communications between the Association's elective bodies and the membership. We, the undersigned voting members of the American Sociological Association, do hereby request that certain sections of the Constitution and By-Laws of the Association be submitted in the following amended form for adoption by the membership in a referendum in the manner specified by the existing Constitution and By-Laws:

We do hereby request that the following amended version of Article IV, Section 3 of the Constitution of the Association be submitted for adoption by the membership in a referendum in the manner specified in the existing Constitution:

Article IV, Section 3. The Council shall consist of twenty-four voting members: six ex officio, and eighteen elected, three each from the Association's six voting districts. The ex officio members shall be the President, Past President, President-Elect, Vice President, Vice-President-Elect, and Secretary. Each district shall elect one member for a three-year term each year. No district member shall be eligible for re-election to the Council as a district member until one year after the expiration of her/his term. No individual shall be eligible for re-election as a district member of the Council after she/he has served two such terms.

We do hereby request that the following amended sections of Article II of the Association's By-Laws be submitted similarly for adoption by the membership in a referendum in the manner specified by the existing By-Laws:

Article II, Section 1, a. The President-Elect, Vice-President-Elect, and Secretary-Elect shall be elected by a mail ballot of the members qualified to vote. The term of office of each shall begin one day prior to the date announced for the dose of the Annual Meeting of the Association in the year during which they are elected.

Article II, Section 1, b. Members of the Council shall consist of three representatives from each of the six election districts of the Association. Members of the Committee on Nominations, the Committee on Committees, and the Committee on Publications shall consist of two representatives from each of the six election districts of the Association. They shall be nominated and elected by members qualified to vote in each of the election districts. Their terms of office shall begin one day prior to the date announced for the close of the Annual Meeting of the Association in the year during which they are elected. All meetings of such bodies shall be open to Association members as observers.

Article II, Section 1, c. The areas to be included in the six election districts of the Association shall be determined from time to time by the Council in such a way as to provide approximately equal membership strength in each district. Such re-apportionment of existing districts shall take place at least once in each five years. [Currently, the election districts consist of (1) Alaska, Arizona, British Columbia, California, Colorado, Guam, Hawaii, Idaho, Nevada, Oregon, Utah, Washington, Wyoming, (2) Alberta, Illinois, Indiana, Iowa, Manitoba, Minnesota, Montana, Nebraska, North Dakota, Ohio, Saskatchewan, South Dakota, (3) Alabama, Arkansas, Florida, Georgia, Kansas, Kentucky, Louisiana, Mississippi, Missouri, New Mexico, North Carolina, Oklahoma, Puerto Rico, South Carolina, Tennessee, Texas, Virgin Islands, (4) Delaware, District of Columbia, Maryland, New Jersey, Pennsylvania, Virginia, West Virginia, (5) Maine, Massachusetts, Michigan, New Brunswick, Newfoundland, New Hampshire, Nova Scotia, Ontario, Quebec, Vermont, Wisconsin, and (6) Connecticut, New York, Rhode Island.]

Article II, Section 2. Two candidates for each open position on the Council, the Committee on Nominations, the Committee on Committees, and the Committee on Publications for the one district of the Association in which it is chiefly located may be nominated by each regional association's nominating committee. Any twenty-five members of the Association in each district may also nominate members of the Council and of Committees by petition.

Article II, Section 3. The Committee on Nominations under the chairpersonship of

the Vice-President-Elect shall select two names each for the offices of President-Elect, Vice-President-Elect, and Secretary-Elect. These names shall be placed on a ballot together with the names of petition candidates for the same offices and the names of candidates for the Council and the elective committees nominated as elsewhere prescribed. In addition, one blank space for each position to be filled shall be provided so that any voting member may choose to make a writing-in nomination instead of voting for an appointed or elected candidate. In the same mailing as the ballot, each member will be provided with approximately comparable data on the professional activities of all candidates for all offices.

Article II, Section 3, b. Prior to the time of the meeting of the Committee on Nominations, members shall be invited to suggest names for nomination of candidates for all offices to be elected at large. The Committee shall be guided but not bound by the suggestions received. Prior to the submission of the official ballot for the election, the nominees of the Committee on Nominations and of the regional associations' committees on nominations shall be made known to the voting members. Within thirty days of the date of that notice, voting members may propose additions to the ballot. A voting member who is supported by 25 members for nomination to the Council, the Committee on Nominations, the Committee on Publications, or the Committee on Committees, or by at least 100 members for nomination as President-Elect, Vice-President-Elect, or Secretary-Elect will be placed on the official ballot along with the nominees of the Committee on Nominations and of the regional committees on nominations.

Article II, Section 3, c. The general election ballots shall be sent by first-class mail to the members eligible to vote not later than May 15 of each year. To be valid as votes, they must be returned to the Honest Ballot Association or to an equivalent and specified outside organization by the date indicated on the ballot, which shall be not less than thirty days from the date of mailing. Each member voting shall be required to place her/his signature upon the outer envelope in which the ballot is returned. Once eligibility is confirmed, the outer envelope will be set aside for safe keeping for at least eighteen months, and an inner envelope with the actual ballot in it will be opened by the Honest Ballot Association or an equivalent and specified outside organization. Said organization shall tabulate the election results and prepare a certified statement for publication to the Association membership. The statement will indicate the votes received by each candidate and will account for all ballots received.

Article II, Section 7. The Executive Officer's responsibility in connection with the conduct of elections shall consist of the preparation of the ballots and their mailing to voting members and of providing to the Honest Ballot Association or an equivalent and specified outside organization of a verified list of voting members against which the names of the members voting may be checked. When the ballots have been tabulated, it will be the Executive Officer's duty to publicize the detailed numerical results.

Article II, Section 8. No member may vote for district candidates from more than one district, that of her/his mail address.

Article II, Section 9. By direction of the Council or by action of a membership meeting or by membership petition, mail ballots other than elections may be conducted in the same manner as election ballots.

We do hereby request that the following amended version of sections of Article V of the By-Laws be submitted for adoption by the membership in a referendum by the manner prescribed by the existing By-Laws:

Article V, Section 1. Committee on Publications. a. There shall be a Committee on Publications, consisting of the President, the Secretary, and two members elected from each of the six voting districts of the Association, one each year for staggered two-year terms. The Editors of the Association journals shall meet with the Committee but shall not have votes in its proceedings. The Committee shall choose a chairperson from among the elected members who have served at least one year on the Committee. [as before]

Article V, Section 2. Committee on Nominations. The Committee on Nominations shall consist of twelve members, one elected by the voting membership of each election district of the Association each year for two-year terms. The twelve members of the Committee on Nominations plus the Vice-President serving as non-voting chairperson shall select twice as many names as there are vacancies to be filled for the offices of President-Elect, Vice-President-Elect, and Secretary-Elect.

Article V, Section 7. The Committee on Committees shall consist of twelve members, one elected by the voting membership of each election district of the Association each year for two-year terms. The Committee shall elect a chairperson from among those who are serving their second year as members of the Committee. Subject to the instruction and approval of the Council, the Committee on Committees shall propose the names of members to serve on the various committees of the Association, other than those committees whose selection or membership is specified otherwise in the Constitution or By-Laws. The Committee on Committees

shall propose to the Council two candidates for each committee position. The candidates shall be submitted paired, and the Council shall choose one or the other of each pair.

The foregoing amended versions are intended to replace the existing versions of Article IV, Section 3 of the Constitution and Article II, Sections 1, 2, 3, 7, 8, and 9 and of Article V, Sections 1, a, 2, and 7 of the By-Laws.

This petition calls for specific amendments to the ASA Constitution and By-Laws. Under the Constitution, such a members' resolution, if rejected by Council, must be submitted to the voting members for a referendum. If accepted by Council, it would be submitted to the voting members for adoption or rejection. Council held a thorough and lengthy discussion resulting in the following action:

MOTION: That the Council reject the petition and prepare a statement noting reasons for maintaining the existing constitutional arrangements as opposed to the proposed petition. Carried with one opposing vote.

The referendum will be accompanied by a statement of resolution, Council's position in favor of maintaining the present Constitution and By-Laws. Council will act on this statement at its March meeting. A statement in favor of the petition will also accompany the referendum.

17. New Business. Council decided to hold its March meeting in Washington, D.C., as its first open meeting. An announcement to this effect will appear in FOOTNOTES.

MOTION: That the Executive Specialist be empowered to speak on behalf of the Association at a forthcoming meeting with the Secretary of HEW, reiterating Council's repeatedly endorsed position on affirmative action. Carried.

MOTION: That a statement be prepared by Joseph Fichter for Council consideration urging that an item on religious preference be included in the 1980 Census. Carried.

Discussion following this motion brought out concern as to the legality of such a question and a recommendation that the statement be referred to the committee on Government Statistics in relation to ASA interests in research and constitutional considerations.

MOTION: That a question on "head of household" designation in the Census be referred to the Committee on the Status of Women in Sociology with recommendations brought to Council at the March meeting. Carried.

There being no further business, the meeting was adjourned at 3:30 p.m. on Saturday, December 6.

Conference on Measurement of Social and Economic Data and Public Policy

In 1974 Gideon Sjoberg and W. Boyd Littrell of the University of Texas at Austin received a grant from the ASA Committee on Problems in the Discipline, to advance work on the "hidden side" of bureaucracy. In order to cast the issue into a broader context, they focused upon a theoretical problem, the relationship between the theories of organization and problems of measurement and upon a substantive topic, the measurement of socio-economic data and public policy. The following paragraphs are edited excerpts from their report:

Many of the issues associated with policy research are familiar. Experts, often from diverse fields, produce technical data which legislators, judges, and administrators, translate into public policy. Policy makers often lack expertise in any technical discipline and rarely are conversant with all relevant technical areas. That policy is created amidst rapidly changing socio-cultural conditions is an added complication.

But there are less familiar issues. Little is known, for instance, about the relationship of bureaucracy's hidden side to data collection and public policy. Today the issues of confidentiality, privacy, and secrecy have taken on special significance. Social scientists, until recently, have generally dealt with these problems in terms of individual rights and responsibilities. But the protest movements of the 1960's, the Viet Nam War, Watergate, and a host of nationally publicized scandals have underscored the need for accountability of organizations and public officials.

In various instances, official data, the staple diet of most policy researchers, are of dubious worth. Needed data may not exist, or they may be withheld from researchers by powerful organizations.

A Conference on the Measure-

ment of Social and Economic Data and Public Policy was organized to explore these issues. This conference, held in Austin, Texas in April 1975, received financial support, in addition to ASA funds, from various sources at the University of Texas. The participants were asked to address themselves to one or more of the following questions: (1) What kinds of knowledge are required that are not now available? (2) Which agencies currently collect data in a given area for policy purposes and what barriers do such agencies encounter in acquiring valid data? (3) From which sources are new demands for information arising—e.g., legislative bodies, the courts, other interested agencies? (4) How do the issues of confidentiality, privacy, secrecy, and accountability affect the collection, measurement, and use of data?

Persons from divergent substantive areas presented working papers. The program included sessions on (a) Mental Health and Delivery of Health Services; (b) Illegal Immigration and the Labor Force; (c) Energy Policy; and (d) Crime and the Other Economy.

Several themes, common to the divergent problem areas emerged, including the ambiguity and the uncertainty of data, "behind the scenes massaging" of data, regional vs. national data sources, and ethical issues regarding justice and fairness. Also the significance of interdisciplinary cooperation, especially taking into account the contributions of lawyers to theory and research in public policy, was underscored.

Negotiations are underway to have the papers published. Investigation will continue of ways in which organizational contexts influence the translation of social science data into public policy. The two organizers of this project welcome correspondence from those interested in these issues.

Appeal Procedures Outlined by NSF

NSF has announced appeal procedures for rejected proposals in a recent notice (No. 61) to all universities and other grantee organizations.

If an applicant for grant assistance received a declination, an opportunity to obtain an explanation from the appropriate Program Director is available. If, upon receipt of this explanation, the applicant has reason to believe the proposal did not receive a fair and impartial initial evaluation, various types of reconsiderations are accessible. The Principal Investigator may request in writing that the Foundation reconsider its action providing such request follows the solicited explanation of refusal from the Program Director; and is postmarked or received by the Foundation no later than 180 days following the date of declination.

The designated official of NSF shall reexamine the procedures followed in the initial evaluation to determine whether the proposal had received fair consideration. Such official may request additional information and, if deemed necessary, additional peer review comments.

If reconsideration reaffirms the declination, the Principal Investigator will be informed of the availability of further reconsideration by the Deputy Director of NSF. The request for reconsideration must be submitted by the institution or individual who filed the original proposal. This request must also be received within 180 days following the results of the first reconsideration. It need not be in any particular format, but must be in writing and signed by the authorized institutional representative and the principal investigators. It must also include the proposal number, if any, title of proposal, and the reasons why it is believed that an error occurred in the evaluation along with all pertinent facts and circumstances in support thereof. Once a decision has been reached by the Deputy Director, no further reconsideration will be made of the proposal. This does not preclude the submission of a substantially revised proposal in the same program area for consideration as a new proposal.

The Decline of Academic Morality

"The erosion of moral standards in the academic community has been proceeding for some time in a gradual, barely perceptible way, but it has reached a point now where the evidence of it exists in many forms and is, cumulatively, according to disturbing proportions," according to Sandy Thatcher in a recent article in the *Princeton Alumni Weekly*.

Thatcher, social science editor at the Princeton University Press, stated that "Theft is the most blatant form such unethical behavior assumes." After discussing theft from campus bookstores and libraries, particularly student "rip offs", he continues:

"But students are not the only thieves hiding in the groves of academe. Some of their profes-

sors, too, have been known to play the game. Publishers who display books at academic conventions, for instance, no longer are surprised when they find books missing at the end of an exhibit, so accustomed are they now to the pilfering that has become an established tradition at such gatherings of our intellectual elite. Only a few weeks ago five books were stolen from the Princeton University Press's booth at the American Sociological Association's annual convention in San Francisco during the last five minutes of the closing day of the exhibit; during the time it took me to track down the sociologist who had walked off with the first book, the other four disappeared from the unattended booth."

The Year the Annual Meeting Stood Still

The year was 1981. Kansas City had been selected as the site, largely because the ASA Council had determined by a ten to eight vote that it was about equal distance from everywhere. After several preference polls of the membership, the dates for the Annual Meeting had finally been set for the first two weeks starting July 4.

A hard-working and harmonious Program Committee had labored long to organize this 76th annual gathering of sociologists. While the total ASA membership had not increased markedly in over a decade, more and more sociologists, members and non-members, individuals and organized sub-groups, sought access to the program. Individual participation was highly prized, perhaps only second to commanding facilities for round-the-clock expression of special-interest concerns. The 1981 Program Committee responded enthusiastically to each and every request for participation and accommodations. Thus the birth of the first two-week Annual Meeting in ASA history.

When the Preliminary Program was issued, the scale of participation became readily apparent. A total of 4,898 persons were to be involved in 982 scientific and professional sessions. This included twelve Plenary Sessions and thirty-two Plenary Panels

organized by Joyce Montgomery (a great, great-granddaughter of the first ASA President, Lester Ward) around the theme, "Whither Sociology?"

The size of the Annual Meeting had also been nourished by the continuous growth in the number of Sections, a trend started in the mid-1970's. There were now forty-one ASA Sections, with the most recent inclusion of the Section on Non-Critical Sociology and the Section on Extraterrestrial Sociology. With this number of Sections, it became necessary to round up every round table in Kansas City in order to stage, in four giant ballrooms, a continuous flow of workshops and informal sessions for the presentation of preliminary findings from pilot studies.

Apart from this expansion, the structure of the program remained remarkably similar to those of earlier years. To be sure, more social events had to be invented to be added to DAN and ROAST to follow the evening plenary sessions. Thus, events such as NASTY (non-academic Sociologists talent Yap) and UGH Undergraduate-Graduate-Hooahaw became part of the regular festivities.

Other features of the meeting had also maintained a resemblance to earlier forms. To be sure, hard-cover books had long since

disappeared to be supplanted by microfiche readers and computer printout machines in the publisher's exhibit halls. And there were now five instead of the traditional two business meetings which provided an ample flow of resolutions to insure the overhaul of the constitution each year.

There was also a significant increase in the number of prizes and awards offered on an annual basis by the ASA to supplement the recognition traditionally accorded via the Sorokin, Stouffer, and Du Bois-Johnson-Frazier Awards. For example, prominent among the new prizes was the annual Dennis Wrong-Charles Wright Ethics Award and the Howie Becker Brownie Award for the best sociological photo of the year.

Despite these continuities in structure, a number of forces coalesced in 1981 to bring the functioning of the meeting to a near frozen state. Prime among these forces was the continuation in stagflation that had plagued the American economy since 1975. The country had not yet recovered from the failure of the second Ford administration (Reagan had replaced Rockefeller as Vice-President) to halt inflation or to reduce unemployment. University budgets sagged while prices soared. As a consequence, Sociologists, except for those actually

scheduled for participation in the program, were unable to attend the Kansas City meeting.

The result was predictable. Of the 4,898 persons on the program, 4,896 registered for the meeting (at the last minute, Amitai Etzioni and Si Goode cancelled their joint Didactic Seminar on "Toward a Codification of Federal Support for Unfunded Policy Research"). The only other persons in attendance at the meeting were Henry Quellmalz, the loyal and dedicated printer of the ASA journals, and twenty-seven ASA staff members, including an Executive Specialist for Group Flights, and six members of the 1981 Program Committee.

1981, then, was the year that the Annual Meeting stood still. Two new records were set simultaneously. Total registration was at a new high. But attendance at the 982 sessions was at a new low. In fact, for the vast majority of sessions the only persons in attendance were the persons making presentations in the part of the program.

This proved embarrassing. It also provoked a great deal of talk about starting a new Section on Small Groups.

The ASA Council moved with all deliberate speed to respond to this curious state of communication. The problem was immediately pumped into the Council's well-

established long-range planning mechanism. The results were startling.

Armed with innovative Council policies, the 1982 Program Committee set to work to revamp and revitalize the Annual Meeting. Advanced technology came to the rescue. The six members of the 1982 Program Committee, loaded with the latest audio and visual machinery, visited every region of the country and recorded the presentation of papers, didactic seminars, workshops, roundtable discussions, plenary panels, and even the presidential address for 1982. Everyone who wanted to participate in the program was welcomed and recorded. Another new record in participation was set. Coupons were attached to the Preliminary Program. Members could now simply request recordings of whatever sessions they desired.

1982 thus marked a new beginning. It was the first Cassette Convention in ASA history. Expenses were cut to the bone. Travel was eliminated. Time and place decisions were obviated. Child care was obliterated. Resolutions were adumbrated. Interaction was simulated. Ideas were communicated.

Through the whirl of cassettes, the Annual Meeting no longer stood still.
