- **-Treasurer Report from Kenzie Latham Mintus (communicated by Brown)**: The section is in good financial standing. As of July 30, we have \$6000 of net assets. This doesn't reflect RSSD donations which will be deposited in the next few weeks and doesn't reflect expenses for ASA

conference. The reception is typically expensive but this year we partnered with CITAMS. We are only paying about 1/3 of what usually pay  $\sim$ \$1000. Please come to section reception (level 5 grand ballroom in Marriot salon E at 6:30p on Aug 19). Also note a change in procedure – we need to complete a form for when we receive donations – ASA council has to give approval for large donations (\$5000) but they only meet at certain times.

- -Membership Committee Report from Alan Santinele Martino: Due to life events, some things were delayed. We have tried to gauge from folks what their perception is, and there are lots of concerns about pandemic and accessibility people have not renewed memberships that's why remote jamborees happened need to have a more formal way to hear people's concerns about this. Also co-chair in disability council of SSSP there's room for collaboration That section has a webinar on mentoring grad students used social media to get a sense of what topics people wanted to hear about. That's the strategy we will use for this year. Students find these three, four days of conferencing energizing but then feel isolated after want a way to stay in touch more regularly webinar could be one way and then mentoring too
- -Robyn Brown: Alan is being humble because our section has grown and importantly, we're over 200 now.
- -Brian Gran asked whether ASA will play with SSSP. Robyn responded that we looked into logistics of having a combined reception and noted ASA's responsiveness meeting services indicated they are willing if we assert that this is what we're doing they will provide space where people with SSSP badge can come to an ASA event
- **-Publicity Committee Report from Gabriele Ciciurkaite**: I led the move away from listserv to ASA connect and will be leading the move back, probably early September will be the first listerv email and will do it every two weeks. Noted section has a very active twitter/x account: 1136 followers. We also have an Instagram, facebook accounts but twitter is the most engaged... very much looking for an interested grad student who loves tweeting.
- **-Program Committee Report from Kerry Dobransky**: I was fortunate to have met with Michelle Maroto when took over great at providing tips were able to get four sessions for this year by partnering with CITAMS for both sessions and receptions. We were also able to partner with race, gender, and class for the session tomorrow at 8a there are some exciting possibilities for some similar collaborations for next year.
- -Nominations Committee Report from Allison Carey: Robyn already went over outgoing and incoming council members. Thanks for all who ran. Upcoming positions are: incoming chair, program committee, publicity, membership, and student representative. We need two people to run for every position it's an ASA requirement so sign up even if you see someone else expressed interest. You may also want to just serve on a committee the awards committee is a fabulous one to serve on. There's a sheet going around for interest in being nominated.

Encourage your library to purchase it because it's expensive. V. 14, edited by Heather Dillaway, Carrie Shandra, and Alexis Bender on the lifecourse, is out online. Volume 15 is under construction by Robyn & Gabby; they are anticipating 11 chapters and intro. And we now have the call out for volume 16, about the future of work(ers) and disability. The call is active and October 1, 2023 is the due date. # Secretary/Treasurer Report Kenzie Latham Mintus

The section is in good financial standing. As of June 30<sup>th</sup>, we currently have \$6,967 as net assets. This number does not reflect the Volume 13 and 14 donations from RSSD (total: \$3,114), which should be deposited in the next few weeks. Additionally, this amount does not reflect any expenses

for the ASA conference including the reception. The reception is typically our largest expense. I am unsure of this year's budget, but in the past it has ranged from \$2,000-2,500.

One thing to note that is a change in procedure is that we must complete a fundraising proposal (see attached for example) for each set of donations from RSSD. Donations over \$5,000 must be approved by the full ASA council and are accepted only during specific times, so completing a proposal for each donation allows us to receive funds on a rolling basis without the full council approval.

# **Publicity Committee Report**

#### **Gabriele Ciciurkaite**

In 2022-2023, the section used five platforms for communicating with section membership.

- 1. The section Listserv used to be our primary means of disseminating section-related announcements (circulated twice-monthly) until ASA changed their communication system to ASA Connect in the Fall of 2022. Gabriele Ciciurkaite, Communications chair, continued to curate the Listserv after taking over this position from Tara Fannon in August, 2022. Additionally, Gabriele Ciciurkaite oversaw the transition to ASA Connect in September, 2022, and continued to disseminate section-related announcements there. Given that ASA will discontinue using ASA Connect as the main communication platform, the section will be going back to primarily using the Listserv to communicate regarding the following: 1) Member accomplishments; 2) New disability research; 3) ASA-related announcements; 4) Funding and mentoring opportunities; 4) External events of relevance.
- 2. The section also has an active Twitter/X account, which is overseen by our section's student representative Jordan Foster. Twitter activities include following section members, tweeting and retweeting member accomplishments, and announcing ASA deadlines. As of August 9, 2023, the account follows 611 other accounts, has 1,136 [up from 1,128 followers]. The account can be found here: https://twitter.com/ASADisability
- 3. The section's also maintains a Facebook account. It is a public account largely populated by content from contributing section members. It currently has 218 members [up from 208],

- 4. The section also created an Instagram account primarily administered by section member Jordan Foster. The account has 53 followers (up from 29) but it hasn't been as active as we would have liked. DEI goals: Communication with section members and potential members to increase involvement and diversity has been and will continue to be a major priority for the Publicity Committee. The committee currently consists of the chair and one graduate student (of different genders and nativity statuses). Even though we advertised a position for a graduate student social media/web representative and circulated it widely (including information about the \$250 stipend with the goal of increasing DEI) across our communication channels, we could not fill this position. The committee will continue to work on the goal of increasing diversity and participation of graduate students in 2023-2024.

# Describe the Section's diversity, equity, and inclusion goals. What steps were taken this year to achieve those goals?

For the period between September 2022 and August 2023, the Disability in Society section's organizing goal was to maintain strides made in recent years regarding diversity, equity, inclusion, and accessibility, while (1) facilitating ties with other sections in order to advance the exchange of diverse ideas and viewpoints within the organization more broadly, and (2) exploring additional ways of enhancing section members' inclusion and sense of belonging. The section leadership shared an understanding that diversity, equity, and inclusion efforts work best when they are based on consensus and collaborative work, and support a group dynamic based upon a common collective vision. To this point, section goals were pursued collaboratively through the section's major activities in conference programming, organizing additional opportunities for engagement, and membership communication.

Specifically, toward the goal of facilitating ties and encouraging more diverse disciplinary discourse, we successfully pursued new conference programming collaborations with two sections: the Race, Gender, Class (RGC) section and the Communication, Information Technologies, and Media Sociology (CITAMS) section, as noted. Expanding on scholarly exchanges at the annual meeting, section members who are involved in the co-sponsored session with CITAMS had an opportunity to publish their research in a special issue of the journal Information, Communications & Society. Additionally, we co-sponsored our conference reception with the CITAMS section this year in order to further encourage cross-disciplinary discussions.

Addressing the inclusion of section members in the ASA remained a priority and a key concern to the section, but it is also bigger than the section and connected to organizational policies and practices concerning accessibility. Thus, section leadership maintained their unique advocacy role within the organization through well-established working relationships with ASA leadership and the Committee on the Status of Persons with Disabilities in Sociology, while additionally offering opportunities for engagement through section activities and channels of communication.

To address the diverse interests of section members, the membership & mentorship chair developed and implemented a survey to identify priorities for section activities. The membership chair remained a constant source of information and support to section members building on these findings. Also, we are mindful that section members may continue to temporarily transition into and out of formal (paid) ASA membership due to ongoing budget restrictions at many universities and colleges. This is an equity issue, and one that we have addressed by maintaining the section's active social media presence to support a sense of community inclusive of those whose membership may be temporarily paused.

Finally, the section's utilization of the ASA Connect platform was an important component of our DEI plan because it sought to engage all section members in direct communication with one another rather than relying on a newsletter administrator to deliver information. The section council will continue to evaluate the DEI goals to inform future efforts, and particularly in terms of communication failing the retiring of the ASA Connect platform.

### **Equity, Diversity, and Inclusion**:

In programming for this year's conference centered EDI in at least a couple of ways. First, the section's cosponsoring sessions with other ASA sections not only expanded the overall amount of disability-related content, but it also promoted diverse perspectives within that content. Second, in lieu of Association-wide decision-making and communication regarding accessibility concerns for in-person conferences, the section decided to communicate early – in our call for papers – that we were committed to making the conference accessible and would work with those participating to do so. The goal was to signal inclusion BEFORE the submission deadline so prospective participants could make informed decisions regarding participation in the conference.

With the success of this year's programming collaborations with other sections, the section will continue to explore opportunities for cross-fertilization and networking with other sections of ASA.
